Re: Grover, Shane - Application for Refund of Real Property Taxes

Mr. Grover purchased three contiguous parcels in the Village of Spencer (parcels 68.12-2-22, 23, 24) per deed instrument 2007-00151165-001 recorded at the Tioga County Clerk on 11/26/2007. Mortgage instrument number 2007-00151165-002 was recorded concurrently, and covers all three parcels.

The parcel that this application pertains to is parcel 24. Attached aerial map shows a house on parcel 23, with parcels 22 and 24 being vacant with possible small improvements. However, a review of the RP database record for parcel 24 shows that for at least the last 10 years the parcel inventory has included a house identical to the actual house in parcel 23. This resulted in an assessed value of \$136,000. (See attached 2021 assessment summary and property record.) Spencer Assessor has updated the inventory for the 2022 roll, removing the house, and assigning a more appropriate value of \$5,000. (See attached 2022 assessment summary and property record.)

Note that Mr. Grover was unaware of the inventory discrepancy until this year. His parcels were all covered by the escrow account of the mortgage, so he never saw a tax bill.

Tax bills and computed refund breakdown for the last 3 years attached.

This is an error in essential fact per paragraph 3 (b) of RPTL section 550.

Recommend approval.
